REGULATIONS:

- 1. This form must be submitted for approval by The Calgary Exhibition and Stampede, by any Exhibitor who wishes to sample, demonstrate, or sell food or nonalcoholic beverage products that will be consumed on site.
2. All products being sold or sampled must be pre-approved by the Calgary Exhibition & Stampede.
3. It is the responsibility of the Trade Show Manager to submit a list to Stampede Park naming all Exhibitors that will be sampling, demonstrating, or selling food, for approval by the Concession Manager at least 14 days prior to show date.
4. It is the responsibility of any Exhibitor that will be sampling, demonstrating, or selling food to submit this agreement to Stampede Park for approval by the Concession Manager at least 14 days prior to show date.
5. Exhibitors must comply with all health and safety regulations as outlined in Food Regulations, Public Health Act (Province of Alberta) plus Calgary Board of Health "Food Establishment Policy". 6. CES Food and Beverage will not approve any items that compete with our menus.
7. Alcohol samples and sales are not approved on this agreement, but must be submitted for approval on the "Alcoholic Beverage Exhibitor Agreement".

Free Samples:

- 1. Samples / giveaways will be assessed, approved or disapproved by CES.
2. Samples / giveaways may be subject to a "Rights Fee".
3. Sample items must be restricted to a maximum 2-ounce liquid portion or a toothpick size food portion.

Items Being Sold:

- 1. Exhibitor agrees to pay 20% + GST commission on gross sales. Payment is to be made nightly and within twenty (20) minutes of the event closing, to the Concession stand at the front of the hall.
2. Exhibitors must keep satisfactory proof of all sales; otherwise the amount payable will be at the discretion of the Concession Manager.
3. Government regulations require GST to be charged on the 20%.
